1. I hereby authorize you to print, publish (in any medium or form, including but not limited to print, electronic, video, website, etc.) and in any subsequent reprint or reuse of the material or photo of my image and my family's image. I have signed this materials or photo/image release form for myself/business only, or as the parent/guardian of a minor (child not of legal age in my state) whose photo was submitted. I am aware that any material submitted by me may be used on the church's website and may be included in supporting promotional material. I acknowledge the publisher/developer's right to crop or treat the material or photo at their discretion. I also acknowledge that the publisher/developer may choose not to use my material or photo at this time and may discontinue the use of this material or photo at any time in the future.

2. I own and/or have obtained all necessary rights and copyrights to allow publisher/developer to publish materials or photos. I SIGNER have obtained the permission of those individuals or legal guardians (committees if an incompetent) of any children pictured in said photos (in any medium or form that exists now or in the future). I have signed this release giving permission to use their likeness for all purposes described above.

3. SIGNER and/or Business hereby agrees to indemnify Greenfield Presbyterian Church/Partner's Ministry, its staff, and web developer and hold harmless against claims, damages and incumbent legal fees that may result from publishing these materials or photos and/or any infraction of the foregoing authorizations.

4. **Publication/Development Website Expenses.** The parties agree that all expenses for publishing and developing the website for Greenfield Presbyterian Church/Partner's Ministry of which the materials or photo/image shall be a part, shall be borne by publisher/developer solely, and the signer/business shall under no circumstances be responsible for any costs or expenses associated with the publication/development or marketing of the website. **Initials** \_\_\_\_\_

**8 Assignment.** This Agreement and the rights and obligations thereunder may not be assigned by either party.

**9. Counterparts.** This Agreement may be executed in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.
